

INSTRUCTIONS

1. NAME	☛ Limited to 30 letters, including spaces and numeral affix. Imported Animals must be registered with the name shown on the Foreign Certificate.
2. SEX	☛ Check appropriate box -- male, female or gelding. Include castration date if known.
3. COLOUR	☛ Write in body colour of foal.
4. DESCRIPTION	☛ Write in complete description of white markings that appear on the animal, including pink facial markings and any dark spots within the white. The right and left side is determined by standing behind the animal facing the direction the animal is facing. The following is a guide for marking(s) and describing animal:
FACE	☛ Usually white. Some exceptions are as follows:
STAR	☛ A white narrow mark on the forehead, located above a line running from eye to eye.
STRIPE	☛ A white narrow marking extending from the line of the eyes toward the line running from nostril to nostril.
SNIP	☛ A white narrow or flesh mark between the nostrils or on the upper or lower lip.
HEEL	☛ A white marking found on the back of the foot.
CORONET	☛ A white marking extending to approximately 1" above the hoof.
PASTERN	☛ A white marking extending to the top of the pastern.
FETLOCK	☛ A white marking extending to the top of the fetlock (ankle).
LEGS	☛ Usually white.
SPOTS	☛ Pigmented spots located within white.
5. BIRTH DATE	☛ Write in exact date of foaling (day, month, year)
6. TWINS	☛ Give sex of twin when applicable. If the twin is not reported on the first application, the twin will not be eligible for registration.
7. SIRE	☛ Enter full registered name and number(s). Provide Canadian registration number whenever possible.
8. DAM	☛ Enter full registered name and number(s). Provide Canadian registration number whenever possible.
9. BREEDER	☛ That person who is the recorded owner or lessee of the dam at time of service.
10. BREEDER ID. NO.	☛ Enter breeder's identification number whenever possible.
11. OWNER AT BIRTH	☛ That person who is the recorded owner or lessee of dam at time of FOALING.
12. OWNER'S ID. NO.	☛ Enter Identification number of owner at birth whenever possible.
13. IMPORTER	☛ Enter importer's name and full address.
14. IMPORTER'S ID. NO.	☛ Enter identification number of importer whenever possible.
15. DATE OF IMPORTATION	☛ Please supply the date of importation for imported animals.
16. SIGNATURE	☛ This must be the signature of the owner at birth or the signature of the importer. Partnership or company signatures must be countersigned by the person authorized to sign. --IMPORTANT--Signatures of authorized representatives are NOT ACCEPTABLE unless Power of Attorney is on file at Canadian Livestock Records Corporation.
17. SERVICE CERTIFICATE	☛ Please fill in date(s) of service.
18. SIGNATURE OF STALLION OWNER	☛ Owner of sire at time of service to SIGN with his/her usual signature in ink. Partnership or company signatures must be countersigned by the person authorized to sign. IMPORTANT--Signatures of authorized representatives are NOT ACCEPTABLE unless Power of Attorney is on file at Canadian Livestock Records Corporation.
19. STALLION OWNER'S ID. NO.	☛ Enter identification number of sire owner whenever possible.
20. DIAGRAM	☛ Be sure your diagram matches the description provided in number 4.
